Please refer to your letter No SEEPZ-SEZ/Customs/S/1/Softex77/2016-17/27796 dated November 28, 2018, a copy of which was endorsed to us.

2. Our response on the issues raised is as under:

As you are aware that information in respect of export of software is getting reflected in the EDPMS of RBI. Further action in respect of closure of these entries are taken by the banks of exporters who mark payment realization in EDPMS against relevant bills.

- 2. During the course of our interactions with bankers and coftware exporters we have come across issues related to condenation of delay in filing of Softan form and of carichilation of Softax forms. Software exporters have informed about difficulties in filling softex forms with a delay and getting confirmation from SEZ outhorities regarding cancelled softex form.
- 3. In the past we have written two communications to your office requesting you to take necessary action in respect of cancelled bills (copies of our letters endorsement No. FED.CO. Trade (EXD) 2827/05.31.042/2017-18 dated September 28, 2017 and FED.CO. Trade (EXD) 4979/05.31.042/2017-18
- 4. Since Softex forms have to get reflected in EDPMS, you have general approval of RBI from FEMA angle for condoning delay in submission of Softex forms. Similarly R9I has no objection regarding cancellation
- 5. In view of what has been said above, we request you to please arrange to issue suitable advisory to SEX authorities towards condonation/cancellation letters to software exporters or make suitable amendments in the system, wherever recuired, so that the exporters can get the outstanding data
