

The unit holds LoP dated 02.08.1999 as extended on 03.03.2015 for export of the R&D Services/inter-disciplinary R&D services, Software application development in the area of E-Commerce, Software activities, Software Development, Engineering Services related to R&D, Scientific and Technical Services related to R&D, Development of Prototypes for Inter-disciplinary related to R&D, Placement and supply services of personnel related to R&D, Business Support Services related to R&D, Legal Services related to R&D and Management Consultancy services related to R&D.

The unit, as a part of their continuous efforts to upgrade their facility in line with latest ECO friendly & Cost Effective Technologies aimed at more efficient energy solutions and reducing Carbon foot print, proposed to upgrade the lighting system by replacing CFL lighting system with LED lighting. The unit has applied for permission for procurement LED Lighting Systems.
