MINUTES OF THE 3rd MEETING (2015 SERIES) OF BOARD OF APPROVAL FOR EOU SCHEME HELD UNDER THE CHAIRMANSHIP OF COMMERCE SECRETARY ON 27.08.2015 AT 10:30 A.M. IN ROOM NO. 47, UDYOG BHAWAN, NEW DELHI

3.1 (15) Confirmation of Minutes of the 2nd BOA (2015 Series) meeting held on 19.05.2015.

The BOA ratified the minutes of its 2nd meeting held on 19.05.2015.

3.2 (15) M/s. Deco De Trend, an EOU at Kancheepuram under MEPZ – Consolidation of goods related to manufactured articles and export thereof along with manufactured articles.

The Board approved the proposal of M/s Deco De Trend, an EOU at Kancheepuram under MEPZ for consolidation of following goods related to manufactured articles and export thereof alongwith manufactured articles subject to provision laid under Para 6.01 (k) of FTP 2015-20:

- i. Glass products (Glass Bottles, Glass Chips etc.)
- ii. Ceramic Products (Terracotta, Ceramic Ware etc.)
- iii. Textile Products (Cotton Ribbon, Clothes etc.)
- .iv. Jute Products (Jute bags, Jute clothes etc.)
- v. Wooden Products & Decoration (Wooden Stand, wooden articles etc.)
- vi. Electric Products (Electric Lamps, Electrical Fittings)
- vii. Metal Products (Iron & steel, Brass, Aluminium)
- viii. Paper Products (Handmade Paper, Corrugated Paper)
- ix. Sea Products (Sea Shells, Star Fish Bones etc.)
- x. Exfoliated Vermiculite (Perfumed)
- xi. Plastic Products (Plastic Balls, Plastic Containers etc.)

3.3 (15) M/s. Emcure Pharmaceuticals Ltd. – Proposal for conversion of DTA unit into an EOU under SEEPZ

The Board approved the proposal of M/s. Emcure Pharmaceuticals Ltd. for conversion of DTA unit into an EOU subject to the conditions laid down in FTP and HBP.

3.4 (15) M/s MKU (P) Ltd. (Optics Division), an EOU at Kanpur under NSEZ – Extension of LoP for 5th year

The Board considered the proposal of M/s MKU (P) Ltd. (Optics Division), an EOU at Kanpur for extension of LoP for the 5th year and decided to extend LoP for the 5th year i.e from 12.05.2015 to 11.05.2016.

3.5 (15) M/s Geetanjali Woolens and M/s Prayas Woolens, EOUs under KASEZ-Proposal for extension of LoP of units engaged in reprocessing of used/worn clothing.

DG, DGFT stated that there should be uniformity in procedure for SEZs and EOUs in extension of LoPs. In SEZs, extension of LoP of the existing units involved in the

business of reprocessing of used/worn clothing is allowed, and whereas the extension of LoP is not allowed for EOUs as per provisions of FTP. He informed BoA that Public Notice has been issued on suggestion of EOU Division of DoC, and therefore BoA is empowered for extension of LoP of existing units and therefore extension of LoP of both units may be considered for one year. Accordingly, after deliberations, the Board decided to extend the LoP in respect of M/s Prayas Woolens Pvt. Ltd. and M/s Geetanjali Woolens Pvt. Ltd. located in Gujarat upto 31st August, 2016.

3.6 (15) M/s Sapling Agrotech Pvt. Ltd. – Proposal for revalidation of their LoP which was cancelled by DC, FSEZ.

The Board considered the proposal of M/s Sapling Agrotech Pvt. Ltd. for renewal of their LoP. After deliberation, the Board deferred the proposal and directed DC, FSEZ to give personal hearing to the unit to ascertain their plan of action to re-commence the production alongwith the details of the investors, and clearing all pending dues as directed by DGFT vide its order dated 22.06.2015.

3.7 (15) M/s Canfruit Exports India Ltd. – Proposal for revalidation of their LoP which was cancelled by DC, VSEZ.

The Board considered the proposal of M/s Canfruit Exports India Ltd. for revalidation of their LoP. After deliberations, the Board gave directions for joint inspection by DC, VSEZ and Central Excise Authorities to verify the production capability and the facts submitted by the unit. After ascertaining the factual status, DC may consider extension LoP for a period of 1 year on merit.

3.8(15) M/s Jain Grani Marmo (P) Ltd., an EOU at Udaipur under NSEZ-Permission for disposal of rejects and waste/scrap into DTA.

The Board considered the proposal of M/s Jain Grani Marmo (P) Ltd., an EOU at Udaipur for enhancement of level of disposal of rejects and waste/scrap into DTA and after deliberations, the Board decided to refer the proposal to the Norms Committee of DGFT to fix the wastage norms.



Amendment in Item No. 3.5 (15):

For:

"DG, DGFT stated that there should be uniformity in procedure for SEZs and EOUs in extension of LoPs. In SEZs, extension of LoP of the existing units involved in the business of reprocessing of used/worn clothing is allowed, and whereas the extension of LoP is not allowed for EOUs as per provisions of FTP. He informed BoA that Public Notice has been issued on suggestion of EOU Division of DoC, and therefore BoA is empowered for extension of LoP of existing units and therefore extension of LoP of both units may be considered for one year. Accordingly, after deliberations, the Board decided to extend the LoP in respect of M/s Prayas Woolens Pvt. Ltd. and M/s Geetanjali Woolens Pvt. Ltd. located in Gujarat upto 31st August, 2016".

Read:

"The Board considered the proposals for extension of LoPs of the two EOUs engaged in reprocessing of used/worn clothing. It was informed by DG, DGFT that as per recommendations of EOU Division of DoC, a Public Notice no. 31/2015-20 had been issued on 26.08.2015, amending the Hand Book of Procedures of FTP 2015-20, and incorporating an enabling provision that empowers the BoA to consider such cases of renewal of LoP and thereby bringing the provisions related to EOU in line with those existing for SEZs. As such, the BoA is now empowered to consider cases of extension of LoP of such units on case to case basis. DG also pointed out that allowing extension of LoP of such units, while not permitting any fresh unit to come up, is resulting in a monopolistic situation.

The BoA noted that in order to avoid a monopolistic situation and also keeping in mind the likely impact of such units on domestic textile industry, a well-considered policy needs to be evolved, after consulting all stake-holders in the matter. However, as formulation of such a policy would take time, it was decided to extend the LoP in respect of M/s Prayas Woolens Pvt. Ltd. and M/s Geetanjali Woolens Pvt. Ltd. located in Gujarat for one year only, i.e. upto 31st august, 2016".
