MINUTES OF THE 3rd MEETING (2013 SERIES) OF BOARD OF APPROVAL FOR EOU SCHEME HELD UNDER THE CHAIRMANSHIP OF COMMERCE SECRETARY ON 12.06.2013 AT 1000 HOURS IN ROOM NO. 108, UDYOG BHAWAN, NEW DELHI

The 3rd meeting (2013) Series of the Board of Approval for EOU was held on 12.06.2013 under the Chairmanship of Shri S.R. Rao, Commerce Secretary in Room No.108, Udyog Bhawan, New Delhi. The Chairman welcomed all the members of the BOA.

3.1(13) Confirmation of the minutes of the 2nd BOA meeting dated 15.3.2013

The BOA ratified the minutes of the 2nd meeting of BOA held on 15.3.2013.

3.2(13) Request for conversion for existing DTA unit into an 100% EOU - M/s. Modern India Con-Cast Ltd. (FASEZ) -

The BOA considered the request of the Unit for conversion of their existing DTA unit into a 100% EOU for manufacture and export of Silico Manganese and Ferro Manganese and approved the case in terms of para 6.7(d) of FTP as recommended by the DGEP and DC FASEZ.


3.3(13) Request for conversion of existing DTA unit holding EPCG License and Advance Authorization into EOU - M/s. Micro Labs Ltd. (SEEPZ)

The BOA considered the request of the Unit for conversion of existing DTA unit holding EPCG licence and advance authorization into EOU and approved the case in terms of Para 6.7(d) of FTP 2009-14 as recommended by DGEP and the DC SEEPZ.

Cases of Appeal for Personal Hearing

3.4(13) Appeal against cancellation of LOP by M/s. Parmeshwar Creations (NSEZ)

The BoA noted that no representative of the unit had come for personal hearing. The Board deliberated on the issue of cancellation of the LOP of the unit by DC NSEZ. After deliberation, the Board directed DC, NSEZ to give a fresh personal hearing to the Unit, consider all issues related to the matter and pass a speaking order within one month. The unit may approach the BoA if the unit is not satisfied with the order of the DC.
