

2.1 (19) Confirmation of 1st Minutes BOA (2019 Series) meeting held on 25.02.2019.

The BOA ratified the minutes of its 1st meeting held on 25.02.2019.

2.2(19) M/s Brocade Communications Systems Pvt. Ltd., an 100% EOU under CSEZ – Proposal for extension of Letter of Permission for 3rd five year block i.e. from 24.08.2017 to 23.08.2022.


The Board, considered the proposal of M/s Brocade Communications Systems Pvt. Ltd., an 100% EOU under CSEZ and approved the proposal for extension of Letter of Permission for 3rd five year block i.e. from 24.08.2017 to 23.08.2022 for the purpose of providing additional time as requested by the unit for exiting from the EOU Scheme.

2.3(19) M/s Vinayak Infotech, an 100% EOU under MEPZ – Proposal for renewal of EOU status for 3rd five year block period i.e. from 29.04.2015 to 28.04.2020.



APPEAL

2.5(19) M/s Renaissance Jewellery Ltd., 100% EOU under KASEZ – Permission to transfer studded jewellery from 100% EOU to a Laboratory at BKC, Mumbai for quality testing.

The representative of M/s. Renaissance Jewellery Ltd., was present before the BOA and stated that presently, the unit needs to send the goods (studded jewellery) to laboratory at BKC, Mumbai for quality test, have to bring back the goods to EOU in Bhavnagar after test and once again send to Precious Cargo Customs Clearance Centre (PCCCC), Mumbai for export. This process is more time consuming, resulting in avoidable delay in export delivery, increasing transportation cost and also increasing the element of risk during such transits.

BOA considered the matter and rejected the appeal as there is no provision in the FTP 2015-20 to provide for direct movement of goods from the lab for exports. The representative of DGEP also pointed out that permitting such an arrangement could result in abuse of rules/provisions given the sensitive nature of the goods. BOA also desired that the policy in this regard may be revisited in consultation with DGFT and D/o Revenue.


