MINUTES OF THE 2<sup>nd</sup> MEETING (2011 SERIES) OF BOARD OF APPROVAL FOR EOU SCHEME HELD UNDER THE CHAIRMANSHIP OF COMMERCE SECRETARY ON 25<sup>th</sup> MARCH, 2011 AT 11.30 HOURS IN ROOM NO. 47, UDYOG BHAWAN, NEW DELHI.

The 2<sup>nd</sup> Meeting (2011 Series) of the Board of Approval for EOU was held on 25.3.2011 under the Chairmanship of Shri Rahul Khullar, Commerce Secretary in Room No.47, Udyog Bhawan, New Delhi. The Chairman welcomed all the members of the BOA meeting and thereafter agenda was taken up for discussion.

### 2.1(11) Confirmation of Minutes of the 1<sup>st</sup> BoA (2011 Series) meeting held on 14.1.2011.

The Board ratified the minutes of 1<sup>st</sup> Meeting (2011 Series) except item No. 1.3(11) in respect of M/s. Consolidated Coin Company. It was decided that DOR's contention would be examined on file for a final decision.

# 2.2(11) M/s. Sai Advantium Pharma Ltd. for broad banding R&D activities along with the existing items of manufacturing.

The Board rejected the proposal as services and manufacturing activities cannot be clubbed under EOU scheme.

(Action: CSEZ)

# 2.3(11) M/s. Premier Cotton Textiles for conversion of the existing DTA unit into EOU for manufacture and export of cotton yarn.

The Board deferred the proposal in view of the model of code of conduct in force in Tamil Nadu owing to State Assembly elections.

(Action: MSEZ)

### 2.4(11) M/s. Godavari Bio-refinery for conversion of existing DTA unit into EOU for manufacture and export of chemicals.

The Board approved the proposal.

(Action: SEEPZ)

### 2.5(11) M/s. Seco Tools India for conversion of DTA unit into EOU for manufacture and export of cutting tools.

The Board approved the proposal subject to settlement of all outstanding obligations/dues in DTA.

(Action: SEEPZ)



2.6(11) M/s. Taurus India Ltd. - Appeal for broad banding 'steel casting' along with existing items of manufacture.

The representative of the unit appeared before the Board and presented the units' case. DC, NSEZ informed that the 'steel casting' was not the part of the permitted activities in their LOP. Besides, 'brass casting' activity which is the underlying basis put forward by the appellant is not forward and backward integrated with the existing permitted activities and hence, DC, NSEZ did not support proposal. The Board, accordingly, rejected the appeal.

(Action: NSEZ)

#### 2.7(11) M/s Maruti Cottex Ltd. appeal for extension of DTA sale period for one year.

The appellant was not present. The Board dismissed the appeal in default.

(Action: SEEPZ)

### 2.8(11) M/s International Polyplast – Cancellation of validity LOP approved by BOA in its meeting held on 20.3.2008.

The Board after due deliberation decided to cancel the validity of LOP with immediate effect.

(Action : KASEZ)

### 2.9(11) M/s Nutra Specialities for extension of time period for further one year for regularisation of advanced DTA sale.

The Board approved the proposal of extension of one year additional time period from 1.3.2011 to 29.2.2012 for regularisation of advanced DTA sale.

(Action: VSEZ)

### 2.10(11) M/s Renshell Exports for extension of period of NFE calculation for one year beyond 5 years.

The representative of DoR informed that the unit did not achieve positive NFE cumulatively at the end of 2<sup>nd</sup> Five Year Block. The Board, accordingly, approved the proposal for extension of 2<sup>nd</sup> Five Year Block by one year from 31.3.2009 to 31.3.2010 for calculating of export obligation in terms of para 6.5 of FTP.

(Action : FSEZ)
