3.1 (20) Confirmation of Minutes of the 2<sup>nd</sup> BOA (2020 Series) meeting for EOU Scheme held on 26.02.2020.

The BOA ratified the Minutes of its 2<sup>nd</sup> meeting held on 26.02.2020.

3.2 (20) M/s. Krishna Enterprises– proposal for setting up a new unit under 100% EOU Scheme under jurisdiction of KASEZ with lower investment criteria.

The Board considered the proposal of M/s. Krishna Enterprises for setting up a new unit under 100% EOU Scheme with lower investment criteria for manufacturing (assembling) and export of PCB Assembly & Electronics Items:-
