1.1(23) Confirmation of Minutes of the 5^{th} BOA (2022 Series) meeting held on 29.10.2022.

Comments of DGEP on the minutes of the 112th BoA in connection to the renewal of LoA of the plastic recycling units: DGEP vide OM dated 25.11.2022 has stated that on examination of the conditions imposed by the BoA, while extending the validity of LoA on temporary basis, the following issues have emerged for consideration/action:

- (i). Customs is mandated to enforce the allied acts as notified. Notification dt. 27.01.2021 issued by Ministry of Environment and Forest is still in force as on date, which prescribes fulfillment of certain conditions for Plastic Recycling Units of SEZ/EOU. Further, DoC's policy instructions dt. 27.05.2021, based on said MoEF Notification, is also in existence. In order to get the BoA decision implemented, for the units which have not fulfilled these conditions, it appears that MoEF/DoC need to make suitable retrospective modification/amendment in their notification/policy instruction so as to avoid future legal complications.
- (ii). For units to fulfill the short fall of NFE and other export obligations, Development Commissioner concerned shall need to look into the feasibility, and their evaluation reports require to be placed in the next BoA, as stipulated in the Minutes and thereafter the matter is to be monitored on regular basis, for ensuring strict compliance of the conditions imposed by the BoA.
- 1.2(23) Proposal for extension of validity of LOP for the 4^{th} five year block period after expiry of six months of validity of LoP M/s Rajyog Granite Exports and Imports Private Limited (formerly M/s Prasad and Ramesh Granites Private Limited), EOU under jurisdiction of VSEZ.

M/s Rajyog Granite Exports and Imports Private Limited, an EOU under jurisdiction of VSEZ was issued LOP on 21.02.2005 for manufacture and export of Granite Slabs. The unit commenced its production on 08.11.2006. The validity of the LoP for the 3rd five year block period was expired on 07.11.2021.

As the unit want to shift their business in the domestic market, the unit was granted in-principle exit order dated 13.08.2019 from the EOU scheme with the direction to submit the required documents within six months (i.e. before 12.02.2020) for issuance of final exit order.

Meanwhile, the unit changed the name of the company from M/s Prasad and Ramesh Granites Pvt. Ltd. to M/s Rajyog Granites Import and Exports Pvt. Ltd. without intimation to O/o VSEZ. Therefore, SCN dated 02.11.2020 was issued to the unit which was adjudicated by imposing a penalty of Rs.10,000/-. The unit paid the penalty imposed. Thereafter, the change in name of the unit was accepted by O/o VSEZ.

Now, the unit has sought extension of LoP for the 4th five year block period from 08.11.2021 to 07.11.2026, after expiry of more than one year of validity of LoP.

The performance of the unit for the 3rd block i.e. upto 07.11.2021 is as under:

Relevant Provision: Para 6.01(i) of HBP 2015-2020 states that "if the units gives their option to continue in the EOU scheme after expiry of 6 months of the LOP, DC will grant extension after obtaining approval of BOA."

DC's Recommendation: DC-VSEZ has recommended the proposal.

1.3(23) Report on renewal of LoPs of the Plastic Recycling EOU units under KASEZ.

The Board in its 5th meeting held on 29.10.2022 decided to extend the validity of LoA on temporary basis of only those units which fulfill the following conditions.

- 1. Units should have been functional and carried out at least some production during the stipulated period of 18 months (i.e. 27th January, 2021 to 26th July, 2022).
- 2. Units should have made at least some exports during the stipulated period of 18 months (i.e. 27th January, 2021 to 26th July, 2022).
- 3. Units shall undertake not to carry out any DTA sales till they fulfil the shortfall of NFE and export obligations for the period upto their period of expiry of validity i.e. 26th August 2022. On fulfillment of shortfall in NFE and other export obligations as stipulated above which shall be confirmed by the jurisdictional DC, and the DC may allow DTA sale to units subject to fulfilling of policy dated 27.05.2021.
- 4. The extension would be granted for a further period upto five years from 27th August, 2022 onwards to align the validity with other units. Such extension shall be on temporary basis only, which will be reviewed by Development Commissioner from time to time.

The Board further directed that the Development Commissioner, KASEZ shall take necessary action accordingly and submit a report to the BoA in the next meeting.

It may be noted that there are 4 plastic recycling units under jurisdiction of KASEZ. DC-KASEZ has granted extension to M/s Prime Exporters and M/s Aaacorp Exim India Pvt. Ltd. for the period of five years in lines of the minutes of BOA. However, LoP of the rest of the two units was not extended by DC-KASEZ as the units have not carried out any exports activity during the stipulated period of 18 months (i.e. 27th January, 2021 to 26th July, 2022).
