NOTIFICATION

S.O. 188(E).- WHEREAS M/s. Lahari Infrastructure Limited, a private organisation of the State of Andhra Pradesh, had proposed under section 3 of the Special Economic Zones Act, 2005 (28 of 2005), (hereinafter referred to as the said Act) to set up a sector specific Special Economic Zone for services sector at Kondakal and Bhulkapur villages, Shankarpally Mandal, Ranga Reddy District in the State of Andhra Pradesh;

AND WHEREAS, the Central Government, in exercise of the powers conferred by sub-section (1) of section 4 of the said Act read with rule 8 of the Special Economic Zone Rules 2006, had notified an area of 108.49 hectares, comprising of the following survey numbers and area as given below in the table at the above location as Special Economic Zone vide the Ministry of Commerce and Industry Notification Number S.O.1549(E) dated 14th September, 2007:-
