3.1 (18) Confirmation of Minutes of the 2<sup>nd</sup> (2018 Series) meeting held on 04.04.2018.

The BOA ratified the minutes of its 2<sup>nd</sup> meeting held on 04.04.2018.

3.2 (18) M/s Roulunds Braking (India) Pvt. Ltd., an EOU under NSEZ – Permission for consolidation of goods related to manufactured articles.

The Board, after deliberations, approved the proposal of M/s Roulunds Braking (India) Pvt. Ltd. for consolidation of following items alongwith the manufactured articles subject to the condition that value of such accessories should not be more than 5% of export made in preceding financial year.

3.3 (18) Proposal for sharing of infrastructure and other facilities between M/s Watson Pharma Pvt. Ltd. and M/s Tevapharm India Pvt. Ltd., EOUs under SEEPZ.

The Board considered the proposal of sharing of infrastructure and other facilities between M/s Watson Pharma Pvt. Ltd. and M/s Tevapharm India Pvt. Ltd., EOUs under SEEPZ. On the basis of recommendation of UAC, SEEPZ, the Board approved the proposal of the sharing of infrastructure facility for common utility of

boiler of M/s. Tevapharm India Pvt. Ltd. to M/s. Watson Pharma Pvt. Ltd, subject to the NFE obligation of the units shall not be altered.

## 3.4 (18) M/s Sree Sunmangala Metals and Industries (P) Ltd. – Proposal for setting up an EOU in Tamil Nadu for manufacture and export of copper ingots.

The Board considered the proposal of M/s Sree Sunmangala Metals and Industries Pvt. Ltd. for setting up an EOU at Kanchipuram District, Tamil Nadu for manufacture of copper alloy ingots from copper scrap birch. The Board took note of the views of DGEP that the unit, besides segregation, is engaged in manufacturing activity of producing copper ingots and therefore it had no objection to the proposal. The Board, therefore, approved the proposal.

### 3.5 (18) M/s Mylan Laboratories Ltd. – Proposal for conversion of existing DTA unit into 100% EOU.

The Board, after deliberations, approved the proposal of M/s Mylan Laboratories Ltd., Telangana for conversion of existing DTA unit into 100% EOU for manufacturing and Export of 'Active Pharmaceutical Ingredients (API's) and Drug Intermediates (Annexure-I)' at Plot No. 5, Road No. 12, JN Pharma City, Tadi Village, Parawada Mandal, Visakhapatnam subject to the provisions laid down in FTP (Foreign Trade Policy) and HBP (Handbook of Procedures) along with the compliance of Appendix 6M of Appendices and ANFs (Aayat Niryat Forms) of FTP 2015-20 for the outstanding export commitment under EPCG and Advance Authorization Scheme.

## 3.6 (18) M/s Big Bags International Pvt. Ltd., an EOU under CSEZ – Order of Hon'ble High Court dated 19.02.2018 for hearing- Appeal against rejection of their request for extension of LoP beyond 27.01.2007

The appeal of the unit was placed before BoA in compliance of the orders of the Hon'ble High Court of Karnataka dated 19.2.2018 in W.P Nos.38304-305/2014. Shri Mehul A Shah, Director, M/s Big Bags International Pvt. Ltd. appeared on behalf of the Unit. The prayer of the Unit was that its application for extension of its LOP for the period from 27.01.2007 up to 29.11.2007 may be approved.

The Board also took note that the Hon' ble High Court in its order dated 19.2.2018 had also pointed this out while directing the Board of Approval to reconsider the matter. The Board noted that the Unit had not adhered to the time limit of three months prescribed in the Foreign Trade Policy for applying for renewal of LOP

The Board desired to know how the Unit was allowed to continue to import and export after 26.1.2007 when its LOP had lapsed. The Board also desired to know the actual practice being followed in respect of cases of lapsed LOP till their revalidation.

The Board decided that the matter may be considered on file after obtaining the LOP extension file of M/s Big Bags International Pvt. Ltd., from MEPZ and a report from the O/o DGEP on the issues mentioned above.
