6.1(20) Confirmation of Minutes of the 5<sup>th</sup> BOA (2020 Series) meeting for EOU Scheme held on 25.09.2020.

The BOA ratified the Minutes of its 5<sup>th</sup> meeting held on 25.09.2020.

6.2(20) M/s Oswal Extrusion Ltd. (EOU under jurisdiction of KASEZ) - Proposal for renewal of LoP for 3<sup>rd</sup> five year block period i.e. 08.01.2020 to 07.01.2025.
