4.1 (19) Confirmation of Minutes of the 3rd BOA (2019 Series) meeting held on 18.06.2019.

The BOA ratified the minutes of its 3rd meeting held on 18.06.2019.

4.2(19) M/s Earth Stone Group, an 100% EOU under NSEZ – Proposal for extension of validity of LOP for a period of one year from 01.10.2018 to 30.09.2019

The Board, after deliberations, approved the proposal of M/s Earth Stone Group, an 100% EOU under NSEZ, for extension of validity of Letter of Permission for a period of one year from 01.10.2018 to 30.09.2019.

4.3(19) M/s Wintac Limited under CSEZ – Proposal for conversion of existing DTA unit into 100%EOU.

The Board, after deliberations, approved the proposal of M/s Wintac Limited for conversion of existing DTA unit into 100% EOU subject to the provisions laid down in Foreign Trade Policy (FTP) 2015-2020 and Handbook of Procedures (HBP) 2015-2020.

4.4(19) M/s KK Wind Solutions India Pvt. Ltd. under CSEZ – Proposal for conversion of existing DTA unit into 100%EOU.

The Board, after deliberations, approved the proposal of M/s KK Wind Solutions India Pvt. Ltd. for conversion of existing DTA unit into 100% EOU subject to the provisions laid down in Foreign Trade Policy (FTP) 2015-2020 and Handbook of Procedures (HBP) 2015-2020.

4.5(19) M/s Greenleaf Extractions Pvt. Ltd. under CSEZ – Proposal for conversion of existing DTA unit into 100%EOU.

The Board, after deliberations, approved the proposal of M/s Greenleaf Extractions Pvt. Ltd. for conversion of existing DTA unit into 100% EOU subject to the provisions laid down in Foreign Trade Policy (FTP) 2015-2020 and Handbook of Procedures (HBP) 2015-2020.

4.6(19) M/s. Mylan Laboratories Ltd., 100% EOU under CSEZ – Request for sharing of infrastructural facilities among EOUs.

The Board considered the proposal of sharing of infrastructural facilities between M/s Mylan Laboratories Ltd. and five other EOUs namely Beta Lactam Division (BLD), Sterile Products Division (SPD), Research & Development Division (R&D), Speciality formulation Facility (SFF) and Onco Therapies Limited (OTL) under CSEZ. On the basis of recommendation of UAC, CSEZ, the Board approved the proposal of the sharing of infrastructural facilities among EOUs, subject to the condition that NFE obligation of the units shall not be altered.

4.7(19) M/s Rawmin Mining and Industries Pvt. Ltd., an 100% EOU under KASEZ – Request of exit from EOU Scheme.

During deliberations, DC, KASEZ suggested that the unit may be granted extension of LOP for next six months to complete the exit formalities from EOU Scheme.

Accordingly, the BOA approved the proposal of the unit and granted extension of LOP upto 31st December, 2019 to complete the exit formalities from EOU Scheme.
