**NOTIFICATION**

**S.O. 1150(E).**- WHEREAS M/s. Bhartiya International SEZ Limited, a private organisation in the State of Andhra Pradesh, has proposed under section 3 of the Special Economic Zones Act, 2005 (28 of 2005), (hereinafter referred to as the said Act) to set up a sector specific Special Economic Zone for manufacture of leather and leather products sector at Villages Konduru, Kadaluru, Akkampeta; Mandal-Tada; District Nellore in the State of Andhra Pradesh;

AND WHEREAS, the Central Government is satisfied that requirements under sub-section (8) of section 3 of the said Act, and other related requirements are fulfilled and it has granted letter of approval under sub-section (10) of section 3 of the said Act for development, operation and maintenance of the sector specific Special Economic Zone for manufacture of leather and leather products at Villages Konduru, Kadaluru, Akkampeta, on the 30<sup>th</sup> July, 2008;

NOW, THEREFORE, in exercise of the powers conferred by sub-section (1) of section 4 of the Special Economic Zones, Act 2005 and in pursuance of rule 8 of the Special Economic Zones Rules, 2006:

(i) the Central Government hereby notifies the following area at Villages Konduru, Kadaluru, Akkampeta; Mandal-Tada; District Nellore in the State of Andhra Pradesh, comprising of the Survey numbers and the area given below in the Table, as a Special Economic Zone, namely:-
