NOTIFICATION

S.O. 1186(E).- Whereas M/s. Magarpatta Township Development and Construction Company Limited, a private organisation in the State of Maharashtra, has proposed under section 3 of the Special Economic Zones Act, 2005 (28 of 2005), (hereinafter referred to as the Act) to set up a sector specific Special Economic Zone for Electronics Hardware and Software including Information Technology Enabled Services at Magarpatta City, Village Hadapsar, Taluka Haveli, District Pune, in the State of Maharashtra;

And whereas, the Central Government is satisfied that requirements under sub-section (8) of section 3 of the said Act, and other related requirements are fulfilled and it has granted letter of approval under sub-section (10) of section 3 of the Act for development, operation and maintenance of the sector specific Special Economic Zone for Electronics Hardware and Software including Information Technology Enabled Services at Magarpatta City, Village Hadapsar, Taluka Haveli, District Pune, in the State of Maharashtra on the 21st August, 2006;

Now, therefore, in exercise of the powers conferred by sub-section (1) of section 4 of the Act and in pursuance of rule 8 of the Special Economic Zones Rules, 2006, the Central Government hereby notifies the following area at Magarpatta City, Village Hadapsar, Taluka Haveli, District Pune, in the State of Maharashtra, comprising of the Survey numbers and the area given below, as a Special Economic Zone namely :-
