NOTIFICATION

S.O. 1458(E).- Whereas M/s. Enfield Exports Limited, a private organization in the State of West Bengal, has proposed under Section 3 of the Special Economic Zones Act, 2005 (28 of 2005), (hereinafter referred to as the Act) to set up a sector specific Special Economic Zone for Information Technology and Information Technology enabled services at Kansa, Panagarh Bazar, District Burdwan in the State of West Bengal;

And whereas, the Central Government is satisfied that requirements under sub-section (8) of Section 3 of the said Act, and other related requirements are fulfilled and it has granted letter of approval under sub-section (10) of Section 3 of the Act for development, operation and maintenance of the sector specific Special Economic Zone for Information Technology and Information Technology enabled services at Kansa, Panagarh Bazar, District Burdwan in the State of West Bengal on 23rd August, 2006;

Now, therefore, in exercise of the powers conferred by sub-section (1) of Section 4 of the Special Economic Zones Act, 2005 and in pursuance of rule 8 of the Special Economic Zones Rules, 2006, the Central Government hereby notifies the following area at Mouza Raghunathpur, Paschim Gangarampur and Harinarayanpur of Burdwan District in the State of West Bengal, comprising of the Survey numbers and the area given below, as a Special Economic Zone, namely:-
