### NOTIFICATION

**S.O. 1559(E).**- Whereas M/s. Welspun Anjar SEZ Limited, a private organisation in the State of Gujarat, has proposed under section 3 of the Special Economic Zones Act, 2005 (28 of 2005), (hereinafter referred to as the Act) to set up a sector specific Special Economic Zone for textile and garment sector at Village Varshamedi, Taluka Anjar, District Kutch in the State of Gujarat;

And whereas the Central Government is satisfied that requirements under sub-section (8) of section 3 of the said Act, and other related requirements are fulfilled and it has granted letter of approval under sub-section (10) of section 3 of the said Act for development, operation and maintenance of the sector specific Special Economic Zone for textile and garment sector at Village Varshamedi, Taluka Anjar, District Kutch in the State of Gujarat on the 26<sup>th</sup> October 2006;

Now, therefore, in exercise of the powers conferred by sub-section (1) of section 4 of the Special Economic Zones Act, 2005 and in pursuance of rule 8 of the Special Economic Zones Rules, 2006, the Central Government hereby notifies the following area at Village Varshamedi, Taluka Anjar, District Kutch in the State of Gujarat, comprising of the Survey numbers and the area given below, as a Special Economic Zone, namely :-
