**NOTIFICATION**

**S.O. 1827(E).**- WHEREAS M/s. DLF Limited, has proposed under section 3 of the Special Economic Zones Act, 2005 (28 of 2005), (hereinafter referred to as the said Act), to set up a sector specific Special Economic Zone for Information Technology and Information Technology Enabled Services at Village Patia, PS : Chandrasekharpur, Tehsil : Bhubneshwar, District Khurda, in the State of Orissa;

And whereas the Central Government, in exercise of the powers conferred by sub-section (1) of section 4 of the said Act read with rule 8 of the Special Economic Zones Rules 2006, has notified the total area of 10.239 hectares at Village Patia, PS : Chandrasekharpur, Tehsil : Bhubneshwar, District Khurda, in the State of Orissa as Special Economic Zone in the Government of India, Ministry of Commerce and Industry Notification no. S.O. 278 (E) dated 7<sup>th</sup> February, 2008;

And whereas M/s. DLF Limited has also proposed to de-notify an area of 10.239 hectares at Village Patia, PS : Chandrasekharpur, Tehsil : Bhubneshwar, District Khurda, in the State of Orissa and the Central Government has granted letter of approval for de-notification of 10.239 hectares at orissa on 5<sup>th</sup> June, 2009;

Now, therefore, in exercise of the powers conferred by sub-section (1) of section 4 of the Special Economic Zone Act, 2005 and in pursuance of rule 8 of the Special Economic Zones Rules, 2006, the Central Government hereby rescinds the notification of the Government of India in the Ministry of commerce and Industry (Department of Commerce) dated 7<sup>th</sup> day of February, 2008 published in the Gazette of India, Extraordinary, vide number S.O. 278 (E) dated the 7<sup>th</sup> February, 2008 except as respects things done or omitted to be done before such rescission.
