NOTIFICATION

S.O. 1977(E).- Whereas M/s Oval Developers Private Limited, has proposed under section 3 of the Special Economic Zones Act, 2005 (28 of 2005), (hereinafter referred, to as the said Act), to set up a sector specific Special Economic Zone for electronic hardware and software at Mouza- Banagram and Sarmasterchowk, District-24 Parganas (South), in the State of West Bengal.

And whereas the Central Government is satisfied that requirements under sub-section (8) of section 3 of the said Act, and other related requirements are fulfilled and it has granted letter of approval under sub-section (10) of section 3 of the said Act for development and operation of the sector specific Special Economic Zone for electronic hardware and software at the said Mouza- Banagram and Sarmasterchowk Area on 21st August, 2006;

Now, therefore, in exercise of the powers conferred by sub-section (1) of section 4 of the Special Economic Zones Act, 2005 and in pursuance of rule 8 of the Special Economic Zones Rules, 2006, the Central Government hereby notifies the following area at Mouza- Banagram and Sarmasterchowk, District-24 Parganas (South), in the State of West Bengal.
