NOTIFICATION

S.O. 2004(E). - Whereas M/s. Jindal Stainless Limited, a fully Private Organization in the State of Orissa, has proposed under section 3 of the Special Economic Zones Act, 2005 (28 of 2005), (hereinafter referred to as the Act) to set up a sector specific Special Economic Zone for Stainless Steel and ancillary/downstream industry at Kalinganagar in the State of Orissa;

And whereas, the Central Government is satisfied that requirements under sub-section (8) of section 3 of the Act, and other related requirements are fulfilled and it has granted letter of approval under sub-section (10) of section 3 of the Act on 25th October, 2006, for development and operation of the sector specific Special Economic Zone for Stainless Steel and ancillary/downstream industry at Kalinganagar in the State of Orissa on 25th October, 2006;

Now, therefore, in exercise of the powers conferred by sub-section (1) of section 4 of the Special Economic Zones Act, 2005 and in pursuance of rule 8 of the Special Economic Zones Rules, 2006, the Central Government hereby notifies the following area at Kalinganagar in the State of Orissa, comprising of the Survey numbers and the area given in the Table below, as a Special Economic Zone, namely: -
