NOTIFICATION

S.O. 2135(E).- WHEREAS M/s. Karanja Infrastructure Private Limited, a private organisation in the State of Maharashtra, has proposed under section 3 of the Special Economic Zones Act, 2005 (28 of 2005) (hereinafter referred to as the said Act), to set up a sector specific Special Economic Zone for Free Trade and Warehousing Zone at Village Chanje, Taluka Uran, District Raigad, Maharashtra;

AND WHEREAS, the Central Government is satisfied that requirements under sub-section (8) of section 3 of the said Act, and other related requirements are fulfilled and it has granted letter of approval under sub-section (10) of section 3 of the said Act for development, operation and maintenance of the above sector specific Special Economic Zone on the 31st October, 2006;

NOW, THEREFORE, in exercise of the powers conferred by sub-section (1) of section 4 of the Special Economic Zones Act, 2005 and in pursuance of rule 8 of the Special Economic Zones Rules, 2006:

(i) the Central Government hereby notifies the following area at Village Chanje, Taluka Uran, District Raigad, Maharashtra, comprising of the survey numbers and the area given below in the Table, as a Special Economic Zone, namely:-

(ii) the Central Government hereby constitutes a Committee to be called the Approval Committee for the above Special Economic Zone for the purposes of section 14 of the said Act consisting of the following members, namely:-

1.	Development Commissioner of the Special Economic Zone	Chairperson ex officio;
2.	Director of Deputy Secretary to the Government of India, Ministry of Commerce and Industry, Department of Commerce or his nominee not below the rank of Under Secretary to the Government of India	Member <i>ex officio</i> ;
3.	Joint Director General of Foreign Trade, Mumbai	Member <i>ex officio</i> ;
4.	Commissioner of Customs or Excise having territorial jurisdiction over the Special Economic Zone or his nominee not below the rank of Joint Commissioner	Member <i>ex officio</i> ;
5.	Commissioner of Income Tax having territorial jurisdiction over the Special Economic Zone or his nominee not below the rank of Joint Commissioner	Member <i>ex officio</i> ;
6.	Director (Banking) in the Ministry of Finance, Banking Division, Government of India	Member <i>ex officio</i> ;
7.	Two officers, not below the rank of Joint Secretary, to be nominated by the Government of Maharashtra	Member <i>ex officio</i> ;

8.	Representative of M/s. Karanja Infrastructure Private Limited (Developer of the zone)	Special invitee.

(iii) the Central Government hereby appoints the 18th day of August 2009 as the date from which the above sector specific Special Economic Zone shall be deemed to be Inland Container Depot under section 7 of the Customs Act, 1962 (52 of 1962).
