**NOTIFICATION**

**S.O. 2184(E).**- WHEREAS M/s. Espire Infrastructure Corporation Limited, has proposed under section 3 of the Special Economic Zones Act, 2005 (28 of 2005), (hereinafter referred to as the said Act), to set up a sector specific Special Economic Zone for Information Technology/Information Technology Enabled Services sector at 12/1, Sector 27-D, Industrial area, Mathura road, Faridabad in the State of Haryana;

AND WHEREAS, the Central Government is satisfied that requirements under sub-section (8) of section 3 of the said Act, and other related requirements are fulfilled and it has granted letter of approval under sub-section (10) of section 3 of the said Act for development operation and maintenance of the sector specific Special Economic Zone for Information Technology/Information Technology Enabled Services including Electronic Hardware sector at Faridabad, Haryana on 26<sup>th</sup> February, 2009;

Now, THEREFORE, in exercise of the powers conferred by sub-section (1) of Section 4, sub-section (1) of section 13, sub-section (2) of section 53 and sub-section 1 of section 11 of the Special Economic Zones Act, 2005 and in pursuance of rule 8 of the Special Economic Zones Rules, 2006 :

(i) the Central Government hereby notifies the following area at 12/1, Sector 27-D, Industrial area, Mathura road, Faridabad in the State of Haryana, comprising of the Survey numbers and the area given below in the table, as a Special Economic Zone, namely:-

3.	Joint Director General of Foreign Trade, having territorial jurisdiction over the Special Economic Zone	Member, Ex-Officio
4.	Commissioner of Customs or Central Excise having territorial jurisdiction over the Special Economic Zone or his nominee not below the rank of Joint Commissioner	Member, Ex-Officio
5.	Commissioner of Income Tax having territorial jurisdiction over the Special Economic Zone or his nominee not below the rank of Joint Commissioner	Member, Ex-Officio
6.	Director (Banking) in the Ministry of Finance, Banking Division, Government of India	Member, Ex-Officio
7.	Two officers, not below the rank of Joint Secretary, to be nominated by the Government of Haryana	Members, Ex-Officio
