**NOTIFICATION**

**S.O. 2254(E).**- WHEREAS M/s. Navi Mumbai SEZ Private Limited, a private organisation in the State of Maharashtra, has proposed under section 3 of the Special Economic Zones Act, 2005 (28 of 2005) (hereinafter referred to as the said Act), to set up a multi-services Special Economic Zone at village Ulwe, Navi Mumbai in the State of Maharashtra;

AND WHEREAS, the Central Government is satisfied that requirements under sub-section (8) of section 3 of the said Act, and other related requirements are fulfilled and it has granted letter of approval under sub-section (10) of section 3 of the said Act for development, operation and maintenance of the above Special Economic Zone on the 27<sup>th</sup> February, 2009;

NOW, THEREFORE, in exercise of the powers conferred by sub-section (1) of section 4 of the Special Economic Zones Act, 2005 and in pursuance of rule 8 of the Special Economic Zones Rules, 2006:-

(i) the Central Government hereby notifies the following area at village Ulwe, Navi Mumbai in the State of Maharashtra, comprising of the Pocket number and the area given below in the Table, as a Special Economic Zone, namely:-

5.	Commissioner of Income Tax having territorial jurisdiction over the Special Economic Zone or his nominee not below the rank of Joint Commissioner	Member, <i>ex officio</i> ;;
6.	Director (Banking) in the Ministry of Finance, Banking Division, Government of India	Member, <i>ex officio</i> ;
7.	Two officers, not below the rank of Joint Secretary, to be nominated by the Government of Maharashtra	Member, <i>ex officio</i> ;
8.	Representative of M/s. Navi Mumbai SEZ Private Limited (Developer of the zone)	Special invitee.
