NOTIFICATION

S.O. 2975(E).- In exercise of the powers conferred by sub-section (1) of section 4 of the Special Economic Zones Act, 2005 (28 of 2005) read with rule 8 of the Special Economic Zones Rules, 2006 and after the grant of the letter of approval on 5th April, 2006 under sub section (10) of section 3, to Maharashtra Industrial Development Corporation for setting up of a sector-specific Special Economic Zone (SEZ) for textile sector at Butibori Industrial Area, District Nagpur, Maharashtra, the Central Government on being satisfied that the requirements under sub-section (8) of section 3 of the said Act and other related requirements are fulfilled, hereby notifies the total area 147.04 hectares as Special Economic Zone at Village - Pohli, Tahsil-Hingna, District- Nagpur in the State of Maharashtra, comprising of the survey numbers and extent of area given in the table, as Special Economic Zone, namely:-
