NOTIFICATION

S. O. 514(E).- Whereas M/s Sunny Vista Realtors Private Limited, a private organization in the State of Maharashtra, has proposed under section 3 of the Special Economic Zones Act, 2005 (28 of 2005), (hereinafter referred to as the said Act), to set up a sector specific Special Economic Zone for services sector at Village Talegoan and panshil, Taluka - Khalapur and Village - Bhokarpada, Taluka - Panvel District Raigad in the State of Maharashtra;

And whereas the Central Government is satisfied that requirements under sub-section (8) of section 3 of the said Act, and other related requirements are fulfilled and it has granted letter of approval under sub-section (10) of section 3 of the said Act for development, operation and maintenance of the sector specific Special Economic Zone for services sector at Village Talegoan and panshil, Taluka - Khalapur and Village - Bhokarpada, Taluka - Panvel District Raigad, in the State of Maharashtra on 15th October, 2007;

Now, therefore, in exercise of the powers conferred by sub-section (1) of section 4 of the Special Economic Zones Act, 2005 and in pursuance of rule 8 of the Special Economic Zones Rules, 2006, the Central Government hereby notifies the following area at Village Talegoan and panshil, Taluka - Khalapur and Village - Bhokarpada, Taluka - Panvel District Raigad, in the State of Maharashtra, comprising of the Survey numbers and the area given below in the Table, as a Special Economic Zone, namely:-
