NOTIFICATION

S.O. 634- (E).- Whereas M/s. Bannari Techno Parks Pvt. Limited has proposed under section 3 of the Special Economic Zones Act, 2005 (28 of 2005), hereinafter referred to as the Act, to set up a sector specific Special Economic Zone for Information Technology and Information Technology Enabled Services at Kalapatty Village, Coimbatore District in the State of Tamil Nadu;

And whereas the Central Government is satisfied that requirements under sub-section (8) of section 3 of the Act, and other related requirements are fulfilled and it has granted letter of approval under sub-section (10) of section 3 of the Act for development and operation of the sector specific Special Economic Zone for Information Technology and Information Technology Enabled Services at Kalapatty Village, Coimbatore District in the State of Tamil Nadu on 25th October, 2006;

Now, therefore, in exercise of the powers conferred by sub-section (1) of section 4 of the Act and in pursuance of rule 8 of the Special Economic Zones Rules, 2006, the Central Government hereby notifies the following area at Kalapatty Village, Coimbatore District in the State of Tamil Nadu, comprising of the Survey numbers and the area given in the Table below, as a Special Economic Zone, namely:-
