NOTIFICATION

S.O. 291(E). - Whereas M/s. Shivajimarg Properties Ltd. a fully Private Organization in the National Capital Territory of Delhi, has proposed under section 3 of the Special Economic Zones Act, 2005 (28 of 2005), (hereinafter referred to as the said Act) to set up a sector specific Special Economic Zone for information technology and information technology enabled services at 15, Shivaji Marg, in the National Capital Territory of Delhi;

And whereas the Central Government, in exercise of the powers conferred by sub-section (1) of section 4 of the said Act read with rule 8 of the Special Economic Zones Rules 2006, has notified the total area of 10.021 hectares at 15, Shivaji Marg, in the National Capital Territory of Delhi as Special Economic Zone in the Government of India, Ministry of Commerce and Industry Notification number S.O. 1453 (E) dated 16th June, 2008;
