

The BOA ratified the Minutes of its 4<sup>th</sup> meeting held on 31.07.2020.

**5.2(20) Proposal for extension of LoP for 5 years i.e. 27.08.2017 to 26.08.2022 - M/s Motherson Sumi Systems Ltd. (EOU under jurisdiction of CSEZ).**



**5.3(20) Proposals for renewal of LOA of Worn and Used Clothing Units & Plastic Recycling units under jurisdiction of KASEZ for next five years i.e. from 01.10.2020 to 30.09.2025.**

The Board, after deliberations, decided to grant extension of validity of LoA of the following worn and used clothing EOUs & plastic recycling EOUs under KASEZ for the next 3 months upto 31.12.2020 or final policy decision whichever is earlier:


