SUPPLEMENTARY AGENDA FOR THE 2nd BOA MEETING (2021 SERIES) FOR EOU SCHEME TO BE HELD ON 18.03.2021 at 11:30 A.M. at Room No. 141 through NIC Video Conferencing.

2.5(21) Proposal for consolidation of goods – M/s Saraf Trading Corporation Pvt. Ltd. (an EOU under jurisdiction of MEPZ).

M/s Saraf Trading Corporation Pvt. Ltd., an 100% EOU under jurisdiction of MEPZ, was issued LOP dated 29.03.2000 for manufacture and export of the following items and all the items of export will be in packets, chestlets and fancy packs, in bulk in tea bags, in ball, brick, tablet, and blender or in such other form:

- i) Tea Bags, Tea in consumer packs, Tea in Chestlets
- ii) Green Tea (with or without flavours)
- iii) Black Tea (with or without flavours)
- iv) Herbal Tea (with or without flavours)
- v) Instant Tea
- vi) De-caffeinated and speciality Teas

The unit commenced its production on 01.07.2000. The LOP of the unit was renewed for the 5th five year period w.e.f. 01.07.2020 and is valid upto 30.06.2025.

The unit has requested for permission of BOA to import Soft Toys, Cups & Saucers, Tins and Kettles and export them as complimentary gift items along with their manufactured products (Tea) as consolidation of goods.

The unit has informed that the goods proposed to be imported without payment of duty would be of value less than 5% of its FOB value of exports in the preceding financial year.

Relevant Provision: Para 6.01(k) of FTP 2015-20 stipulates that, BOA may allow, on a case to case basis, request of EOU in sectors other than Gems and Jewellery, for consolidation of goods related to manufacture articles and export thereof along with manufactured article.

Such goods may be allowed to be imported/procured from DTA by EOU with or without payment of duty and/or taxes as provided at para 6.01(d) (ii) and (iii) above, as the case may be to the extent of 5% FOB value of such manufactured articles exported by the unit in preceding financial year. Details of procured/imported goods and articles manufactured by the EOU will be listed separately in the export documents. In such cases, value of procured/imported goods will not be taken into account for calculation of NFE and DTA sale entitlement. Such procured/imported goods shall not be allowed to be sold in DTA. BOA may also specify any other conditions.

DC's Recommendation: DC-MEPZ has recommended the proposal of the unit.
